GENERAL TERMS AND CONDITIONS (PROMOTIONS AND COMPETITIONS)

Effective date: 8th March 2017.

1. INITIAL PROVISIONS

1.1. Exponea s.r.o., Business ID No. 50017560, with its registered office at Vajnorská 100, 831 04 Bratislava – Nové Mesto, Slovakia, registered in the Commercial Register maintained by County Court in Bratislava I, Section Sro, Insert 107011/B ("Exponea" or "we") may from time to time organise a competition or other promotional activity. This General Terms and Conditions (Promotions and Competitions) ("GTC Promotions") will apply to any such activities of Exponea or its affiliates. An Exponea's promotional activity may also be governed by specific terms and conditions which will be communication within the introduction of competition or other relevant promotional activity. In case of any discrepancy, the specific terms and conditions will have a priority over these GTC Promotions.

1.2. Provisions of these GTC Promotions shall apply from the Effective date stated above.

1.3. Capitalised words not defined in these GTC Promotions shall have the meaning ascribed to such words in the General Terms and Conditions.

2. ELIGIBLE PARTICIPANTS AND PROVIDED INFORMATION

- 2.1. Any person who wishes to participate in any competition or other promotional activities organised by Exponea ("**Promotion**") must fulfil all requirements set out in these GTC Promotions or any specific terms and conditions applicable and/or presented along with the presented Promotion.
- 2.2. Any eligible participant must be at least 18 years old. If a Participant is less than 18 years old, such participant confirms that he obtained approval from their parent(s) for participation in the Promotion. Excluded from participation are staff and relatives of Exponea, its affiliates or its directors, officers or employees, and cohabiting partners or family of the aforementioned persons, as well as any participants/suppliers in respect of the respective Promotion (including advertising agencies, advertisers, sponsors or producers).
- 2.3. - 3.3. The Award is granted in its current state. Exponea is not responsible for any visible or hidden defects in the Award nor for any damage during delivery (shipping) of the Award. The handling of the delivery of the Award is arranged by Exponea, advertiser/sponsor or another appointed third party. In the latter case, Exponea shall not be responsible for the delivery of the Award. The winner of the Award grants Exponea permission to use, free of charge, any received information (including personal data), or any other contributions linked to the Promotion to be used in Exponea's activities relating to the Promotion and in relation to the announcement of the winner through all media.
- 3.7. To the extent required by virtue of applicable legal regulations, Exponea is entitled to arrange any withholdings and/or declaration of taxes, except where specific conditions stipulate otherwise.

- 4.1. Exponea may add the personal information to its databases, which is confidential and will be treated in accordance with Exponea's Privacy Policy and relevant data privacy regulation applicable in the Slovak Republic.
- 4.3. Personal or other information may be used to execute the Promotion. In this context, Exponea is entitled to provide certain identification data to third parties involved in the relevant Promotion (including suppliers, advertisers, sponsors and/or producers). 6. FINAL PROVISIONS

Any dispute arising from or connected with these GTC Promotions and/or specific terms and conditions shall be finally decided by competent Slovak courts.
